# 45th FALL FESTIVAL

### COST:

#### CRAFT VENDORS:

10' space = \$30  
15' space = \$40  
20' space = \$50  
25' space = \$60

#### INFORMATION

**BOOTH:**  
10"space = \$30

#### FOOD VENDORS

10' space = \$50  
15' space = \$60  
20' space = \$70  
25' space = \$80  
30' space = \$90  
40' space = \$100  
85' space = \$225

These fees are based on the size of your booth plus 10% of gross sales when you register before June 30th DEADLINE. You must register by June 30th to reclaim your space from last year. Everyone is encouraged to register early. From July 1- August 31 it will be a \$100 Registration fee for craft vendors for any size booth plus 10% of gross sales as space is available. Information booth - \$50. For Food Vendors registering after June 30, prices will double beginning July 1 – August 31.

Registration fee must accompany application and is NON-REFUNDABLE. Participants are responsible for reporting their own North Carolina sales tax.

### PARTICIPANTS:

People who make what they sell. No booths mixing commercial with handmade goods. **No food or drinks (soft drinks or water) for sale in craft booths.** Fall Festival Staff will check vendor booths for violations. Fall Festival Staff reserves the right to ask any vendor to leave at any time.

### ELECTRICITY:

Randolph Arts Guild does NOT provide electricity. You are responsible for the coordination of your own electricity with Progress Energy. To apply for a temporary account, call Progress Energy at 1-800-452-2777. Permission to use water and/or electricity from local businesses should be accompanied by a signed letter from the business owner and submitted to the Guild prior to the start of the festival.

### FIRE REGULATIONS:

Vendors should use fire retardant canopies. Food vendors using sources of heat should have a fire extinguisher and covers for hot oil cookers. Hot oil cookers should not be used under canopies. Regulations governing open fire, gas grills, etc. should be requested when applicable. The Fire Marshal will inspect booths.

### OTHER INFORMATION:

No tables or props provided. Pets are not allowed at Fall Festival.

### CONFIRMATIONS:

Early Deadline for registration is June 30. Confirmations will be mailed. Final space assignments will not be made until September 15. Visit [www.randolphartsguild.com](http://www.randolphartsguild.com) for booth number after that date. Vendor Packets are available Friday, before the festival, 9:00am-9:00pm at the Arts Guild. On Saturday and Sunday, packets are available at the Information Booth at the intersection of Sunset and Fayetteville beginning at 6:00am.

### PRE-FESTIVAL ACTIVITIES:

There is no rain date for the Festival. (Registration fee is NON-REFUNDABLE.) For information about 10K Road Race call Asheboro Parks and Recreation at 336-626-1240.

### PARKING:

Parking is not controlled by Fall Festival. Free parking is available away from Festival on first come-first served basis. Local non-profit groups control many lots. Rates vary. No accommodation for RV's or campers is offered. Bank of North Carolina parking lot on North Street, along with many other businesses are not available to vendors.
